## **Total Revenue / Revenue Streams**

\$442,867 / Tobacco Settlement Funds, General Fund and Department of Public Safety (VRU Grant)

### **Projected Year End Shortfall:**

-\$39,310. Caused by prior legislative reductions to tobacco settlement allocations. Mitigation plan involves funding augmentation expected in March by shift to differing Director's Office budget authority. No anticipated staffing cuts at this time.

### **Advisory Committee Discussion**

- Clarified that NOMHE remains statutorily required.

## VII. For Information/Discussion Only: Division of Public and Behavioral Health Stroke Registry Report

**Presenter:** Troy Lovick, Cardiovascular Health Program Coordinator

Report purpose: Report on aggregate statewide stroke data. Provide legislative recommendations. Improve stroke care quality across Nevada.

### Key Data:

- 17 Joint Commission–accredited stroke hospitals (all in Clark, Washoe, Carson).
  - Native American population overrepresented in stroke prevalence.

- Rural critical access hospitals need improved stroke readiness.

Recommendation Areas for Legislative Consideration:

- Statewide stroke system planning
- EMS pre-hospital protocols
- Rural hospital inclusion
- Stroke registry & data quality
- Rehabilitation & long-term recovery
- Workforce shortages
- Payment & voucher structures

**VIII. For Information/Discussion Only: Department of Human Services Overview of 2025 Senate Bill 3 and Senate Bill 4 —**

**Presenters:** Kelly Cantrelle, Deputy Administrator and Trenton Sheesley, Management Analyst

The Division of Social Services presented information related to Senate Bill 3 (SB3) and Senate Bill 4 (SB4), which significantly affect access to public assistance and healthcare coverage for low-income and vulnerable populations in Nevada.

These bills carry implications for: Medicaid access, SNAP participation, TANF eligibility, administrative verification processes and health equity outcomes

**Senate Bill 3 (SB3) – Administrative & Eligibility Reforms**

Core Focus:

- Modernization of eligibility verification systems.
- Alignment of eligibility processes across benefit programs.
- Increased fraud detection protocols.
- Strengthened documentation requirements.

**Potential positive impacts:** streamlined eligibility systems; reduced administrative duplication; potential improved interagency data sharing.

**Concerns raised:** Increased documentation burdens; disproportionately impact seniors; create barriers for non-English speakers; delay coverage for Medicaid applicants; risk of unintended coverage loss for vulnerable populations.

**Equity considerations:** Language access; digital access disparities; rural connectivity limitations; disability accommodation compliance.

#### **Senate Bill 4 (SB4) – Public Assistance Policy Adjustments**

Core Focus:

- Adjustments to SNAP and TANF participation standards.
- Work requirement modifications.
- Reporting compliance timelines.

**Potential positive impacts:** alignment with federal standards; potential administrative cost savings; clearer eligibility guidelines.

**Concerns raised:** Work requirement expansions; impact single parents; effect individuals with disabilities; increase churn in Medicaid/SNAP enrollment; reporting requirement changes could; increase case closures due to paperwork; create instability in food security.

#### **Discussion Themes**

- Need for Health Impact Analysis.
- Importance of monitoring enrollment loss trends.
- Cross-sector collaboration between DSS & NOMHE.
- Tracking impacts on minority and tribal populations.
- Ensuring culturally and linguistically appropriate implementation.
