#### Purpose of Funding

This grant will serve as a one-time funding source to enhance services for pregnant and postpartum mothers and their infants in a Medically Underserved Area (MUA). The intent of this funding is to provide 'seed money' for sustainability and foster further inter-agency collaboration in the community. All projects must align with the objectives as outlined on page 4 of this Notice of Funding Opportunity, published on the GMU website.



#### Eligibility Criteria

Existing Federally Qualified Health Centers (FQHCs) and FQHC Look-alikes, as defined by the Health Resources & Services Administration (HRSA), headquartered in Nevada; and Certified Community Behavioral Health Centers (CCBHCS), as defined by the Substance Abuse and Mental Health Services Administration (SAMHSA) are eligible to apply for this funding.

➤ FQHCs are community-based organizations that provide comprehensive primary care and preventative care, including health, oral, mental, and behavioral health services to persons of all ages, regardless of their ability to pay or health insurance status.



#### Eligibility Criteria (con't.)

➤ Certified Community Behavioral Health Centers (CCBHCs) also serve any individual in need of care, regardless of ability to pay. CCBHCs provide outpatient behavioral health services and primary care screenings and monitoring for children, adults and families with the goals to provide community-based mental and substance use disorder services; combined behavioral health and physical health care with no wrong door entry to services; evidence-based practices; improved access to high-quality care; care coordination and case management to address all needs of the individual; and better overall health outcomes.



### Available Funding SFY26/27

DHHS, with approval from the 2017 Nevada Legislature, utilized allocations from the Fund for a Healthy Nevada (FHN) to initiate projects under the FQHC Incubator Project. Since then, the FQHC Incubator Project has continued to focus on increasing access to health care among different target populations. FQHC organizations primarily serve the most vulnerable Nevadans; more than two-thirds of FQHC patients are uninsured, underinsured or utilizing Medicaid, and more than 95- percent live below 200 percent of the Federal poverty level.

Tobacco Settlement Funds have decreased resulting in reduced revenue from the Fund for Healthy Nevada. This has caused a 12.77% reduction in funding in Year 1 and 12.52% reduction in Year 2. For this funding, we received 5 applications in total.
