

**Personal Care Services, Prior Authorization Report (PAR) Study
State Fiscal Years (SFY) 2020 - 2022**

The purpose of this report is to better understand the demographics of the Prior Authorization Reports (PAR) submitted and approved for Medicaid Members.

The target population of this report are all Medicaid members who have had a PAR submitted in the past 3 years (July 2019 through June 2022) for services to be billed under Personal Care Aide – Provider Agency (PT 30), Waiver for the Frail Elderly (PT 48), Waiver for Persons with Physical Disabilities (PT 58), and/or Personal Care Aide – Intermediary Service Organization (PT 83).

There are two possible studies we can complete using the data from the Prior Authorization Reports (PARs).

1. The first study is to become familiar with the populations receiving personal care services (PCS). This is essentially a demographics study.

2. The second study is the quantity at which personal care services are allowed. There are two 'big buckets' of personal care services:

- personal care services billed in 15-minute units

- personal care services billed per 'event' such as a meal or emergency set-up, or adult day care.

This report covers the first study. There are limitations to the second study which need to be addressed before a final report can be released.

The limitation on both studies is knowing the needs of the population. These studies rely on the assumption that persons in the same age group and gender categories would likely have the same alignments that would incline a physician to sign for PCS on a PAR.

The average Medicaid population mostly consists of children and adolescents. Population percent decline as client's age groups increase.

Race, age, and gender categories with no representation of members with PARs for PCS services were removed from population totals.

The average population is based on SFY 2020 - SFY 2022 month over month Medicaid averages.

This table shows the average monthly enrollment (SFY 2020 - 2022) for Medicaid based on age and race. Two percent (2%) of the total Medicaid population has an approved PAR. Of this 2%, females in the age group 64 years and older have had the most approved PARs during the time period.

The next tables will break out the age group and gender of members by race.

Race, age, and gender categories with no representation of members with PARs for PCS services were removed from population totals.

16, 598 members had service units on an approved PAR for PCS at any time during fiscal years 2020, 2021, and 2022.

-Persons in the older age categories are more likely to have an approved PAR.

-Women are more likely to have an approved PAR for PCS compared to men.

-Black females (Hispanic and non-Hispanic) ages 64+ have the highest proportion of the approved PARs. However, only makes up about 7% of the total population with approved PARs.


-White females ages 64+ have the highest percentage of approved PARs when compared to the total percent of approved PARS.

In many of the gender and age Categories broken out by race, small numbers in the denominator effect the higher proportion of persons with an approved PAR for PCS.

Chart 1: Female, Aged 64 or older



Chart 2: Male, Aged 64 or older



Chart 3: Female, Aged 55-64



Chart 4: Male, Aged 55-64



Chart 5: Female 45-54



Chart 6: Male 45-54



Chart 7: Female 35-44



Chart 8: Male 35-44



Chart 9: Female 21-34



Chart 10: Male 21-34



Chart 11: Female 0-20


